### **What developments have taken place at SAST SOLUTIONS?**

SAST SOLUTIONS will remain unchanged as the service portfolio of AES (akquinet enterprise solutions GmbH), with all operating units and with Bodo Kahl and Ralf Kempf as managing directors.

### **What is the Pathlock Group?**

Our group is an international “best of” alliance of seven leading vendors of access governance and application security solutions, in which each company’s services and products complement one another notably. As a new global player with over 1,200 customers and 15 locations in the United States, Germany, Belgium, the Netherlands, the United Kingdom, Israel, and India, our group will operate under the name of the company that is most well-known internationally, “Pathlock”. In addition to Pathlock and SAST SOLUTIONS, the other companies are Appspan, Security Weaver, CSI Tools, Xpandion, and QSoftware.

### **What is the purpose of the alliance?**

Our goal as the global market leader is to raise understanding for the automation of access orchestration and the cybersecurity of all business applications to an entirely new level – with a broad-based solution that can do far more than the classic approach that currently dominates the market.
